COMPETITION RULES

Art. 1 – Aim of the Competition

Riva Industria Mobili S.p.A., a company selling its own solid wood furniture Collection under the registered trademark of **RIVA 1920**, promotes the **Design Award “Light up your idea” Japan Edition** for the design of a **new stool**

Guidelines for materials:

- **Solid wood _ Riva 1920** – scented cedarwood of Lebanon, coming from controlled cut
- **sizes:** seat Ø min.30cm max 40cm - H. 45 cm
- **creation:** the object has to be obtained from a unique piece of cedarwood (maximum height 50 cm, maximum diameter 56 cm) using NC 6 axis machine

Evaluation Criteria:

- **Design:** different from the other Riva 1920 stools, but representative of RIVA 1920 mood
- **Functionality:** easy to produce and easy to use
- **technical feasibility**
- **productive economy**
- **commercial appeal**

Safeguarding the environment and love for nature are fundamental principles for Riva 1920. The quality of the raw materials is the basis of the production process and starts with the selection of those coming from controlled reforestation areas. Each element is subject to detailed quality and functional compliance tests, which combined with the use of vinyl adhesives and vegetable oil and wax finishes guarantee an authentic and completely natural product.

Art. 2 – Conditions of Participation in the Competition

Participation in the competition is **open to everyone coming from Japan**, participation both as individuals and in groups is allowed.

Each participant, as an individual or a group, may submit one, and only one, project.

In the case of participation in a group, the designation of a group leader that will be fully responsible to the organizers of the Competition is necessary.

Art. 3 – Entries

The project submitted must be original and unpublished, under penalty of exclusion from the competition; if the fact was to emerge later, there will be the cancellation of the awards assigned and the subsequent obligation to repay the amount received.

Each participant may enter the contest by going to the website <https://awards.riva1920.it> in the Japan Edition Design Award dedicated section, starting from 1st June 2021.

The registration to the website and the uploading of the project can also be done at different times.

Participation in the competition must be made anonymously.

IMPORTANT: the name of the designer cannot be reported on any of the four sheets. The sheets will have to be anonymous and just indicate the name of the project.

Each participant will have to upload:

- **1 sheet under “Preview of the project”**, strictly in **jpg format** (not exceeding 1 MB, 3000x2000 pixels, 72 dpi). This will be the first sheet analysed by the jury and can correspond to the render or to any other image representing the project you want to show as a preview (general concept of the project). *The sheet must contain the project name.*
- **1 sheet “Render” A3 format** strictly in **PDF format (not exceeding 4 MB)**. *The sheet must contain the project name.*
- **1 sheet under “Technical Drawing”, A3 format**, strictly in **PDF format (not exceeding 4 MB)**. In this section you must enter plans, sections prospects, measures and materials used. *The sheet must contain the project name.*
- **1 sheet under “Description of the project”, A4 format**, strictly in **PDF format** with title (name of the project) and class of participation, with a short description of the project. *The sheet must contain the project name.*

Only one project will be selected.

The total prize money will be € 1.000 (one thousand Euros,00) pre-tax in addition to royalties equal to 4% from the marketing of the new stool.

Art. 8 – Ownership of submissions

The projects submitted to the Jury will remain the property of the Authors; any wish to use the projects will first be explicitly communicated to the Author(s) for permission.

Art. 9 –Production rights

The participants in the Competition retain their rights as Authors of their designs. Should other submitted projects be produced by RIVA Industria Mobili S.p.A. irrespective of the results of the Competition, these will be the subject of a specific contract to be drawn up with the Author.
